#### Message from the President Mary Chesney

As I was thinking about what to write for this month's newsletter, I looked at past president's comments in March. Our previous president, Leslie Gitomer, wrote about equal pay. During a strike in 2000 she learned that she was paid, as a Boeing engineer with many years of experience, much less than her male colleagues with a similar work history. It spurred her on to work toward having her pay increased to that of the men. The sad part is it took six years of working much harder than any other comparable colleague, to make such a strong case, her request could not be denied.

The fight for equal rights has been going on since the 1800's and the solution is long overdue. Recently the state of Virginia passed the Equal Rights amendment, making it the 38<sup>th</sup> state to do so, the minimum number to amend the constitution. If the amendment will be added to the constitution is a bit questionable. Three states, Alabama, South Dakota, and Louisiana have filed a lawsuit to block the archivist of the United States from adding the ERA to the constitution. Visit link below:

Had it been in place when Leslie was working, she would not have faced taking on the work of two people to prove she was worth the same pay as one man.

Equity for All - AAUW's Legacy Challenged and Reaffirmed Jackie DeFazio

As we move into March and a celebration of women's history on the heels of Black History month, let me introduce you, courtesy of AAUW's archives, to Mary Church Terrell, one of the first African American women to earn a college degree. She attended Oberlin College, receiving her bachelor's degree in 1884 and her master's degree in 1888.

After earning her degrees, Ms. Church moved to Washington, D.C., where she met and married Robert Herberton Terrell, the District's first African American



municipal court judge. Her accomplishments there included serving on the D.C. Board of Education from 1895–1906 and being one of the founders of the National Association for the Advancement of Colored People (NAACP).

In 1946, Terrell was invited to join the AAUW Washington (DC) Branch, an invitation that caused a sharp division in the branch when some members opposed her admittance because she was African American. The irony is that Terrell was once a national member of the Association of Collegiate Alumnae (ACA) and AAUW; her name is listed in a directory from 1905–06. And according to some of AAUW's archives, she was also a former member of the Washington branch — the same branch that in 1946 was resisting her membership.

The national leaders of AAUW ordered the branch to accept Terrell's application for membership or be dissolved, because AAUW had never explicitly excluded women based on race in its membership criteria or bylaws. In 1948 the branch sued AAUW in district court and won. AAUW appealed the court's decision but lost. With this controversy unresolved, AAUW President Althea K. Hottel consulted her friend, former Supreme Court Justice Owen J. Roberts, who advised her that AAUW should revise its bylaws to clarify its membership requirements to prevent exclusion by race.

At the 1949 National Convention in Seattle, AAUW members voted overwhelmingly (2,168 to 65) to revise the bylaws so that the only requirement for membership was to be a woman with a college degree from an AAUW-approved university, reaffirming that women college graduates of all races were eligible for membership. The branch members that had opposed Terrell's membership quit AAUW and formed their own group. The remaining AAUW members stood proudly with Mary Church Terrell as have AAUW members ever since.

#### February 1: Scholarship Season is Upon Us Marianne McGarry-Bloom

February 1 marked the opening of our branch 2020 scholarship season. The AAUW (American Association of University Women) Stanwood-Camano Branch is now accepting applications for four \$4,000 scholarships for continuing higher



education for college students. All applicants must be a current resident of the Arlington, Stanwood, or Camano Island area AND/OR be a graduate of Lakewood, Arlington, Stanwood or Lincoln Hill High Schools.

The applicant must have completed at least 2 years of study at an accredited college or university by June of 2020 and have verifiable plans to continue upper-division or master's level post-graduate work at an accredited 4 year college or university in the Fall of 2020. The 2020 application can be obtained through the Stanwood Camano AAUW website: www.aauwsc.org/scholarship or at washboard.org.

All submissions must be postmarked on or before Friday, May 1, 2020. Mail applications to AAUW Stanwood Camano Branch, PO Box 2652, Stanwood, WA. 98292. Questions can be forwarded to the scholarship chair at the AAUW website.

#### Branch Beginnings: Four from Montana, Part 2 Carolyn Spector

Our branch of AAUW was formed in Arlington in 1936 by a group of 16 women. This is one of a series of articles profiling the women who founded our chapter.

Margaret Lucille Dahl was born in Miles City, Montana on November 22, 1909. Her father was a railroad telegraph operator, and the family moved a number of times during her early childhood. The 1910 census shows them living in Lewis and Clark County, Montana, but by 1917 the family had moved to Ellensburg, Washington. The

1920 federal census shows the family living in the small town of Malden in Whitman County, Washington, where her father continued his employment with the railroad. Lucille by then had two younger siblings, Leonard who was born in Montana and Elizabeth who was born in Minnesota.

Lou, as she preferred to be called, was one of the more than 300 delegates to Washington State's first annual high school student convention, held in Spokane in April 1928. Her family was still living in Malden. Lou attended the Washington State College at Pullman, where in November 1928, as a freshman, she joined the Literary Staff of the Cougar's Paw, the college's humor publication. The following year, as a sophomore, Lou was initiated into Spurs, the campus service organization for undergraduate women. By 1933, she was one of the committee members of the Washington State College Advertising Club. Lou was also listed as a graduate member of Alpha Gamma Delta in the State College of Washington 1933 yearbook.

She attended the Inland Empire Education Association convention in Spokane in April 1934, where a newspaper article gave her home as Winona, Washington (a small town northwest of Pullman). By 1935, however, she was teaching Commercial Education at Arlington High School, where she also served as Adviser to the school annual and Pep Club, and was Honorary Advisor to "The Eagle Coterie" Club, whose membership consisted of female students majoring in Commercial work.

While she was one of the founders of the Arlington branch of AAUW, Lou did not remain in Arlington for very long. By December 1930 she was a resident of Sumner, Washington, where she married Rex K. Weick. Witnesses were Mr. and Mrs. Orville Brown; he was a member of the Sumner School Board, which suggests that Lou Dahl had been teaching in that district prior to her marriage, although no record can be found to confirm that. Lou and Rex had a son and daughter.

Lou passed away on Sept. 7, 2006, just a few months short of her 97<sup>th</sup> birthday.

#### Dorm Moms Needed for Tech Trek This Summer Judy Prince

The Tech Trek camper selection committee is moving into the interview process, the last step before camper selection. Because we will send more than 10 girls to camp, we are expected to send one dorm mom. This person, with the help of a student

counselor, is responsible for 10 campers. She sleeps in a dorm room in the midst of her girls (who share 5 rooms). She gathers them in the morning to go to breakfast in the dining commons. Each dorm mom doubles as a teacher assistant for half of each class day. You get half a day free! You get to go on one of the field trips although you are responsible for a small group of girls. We don't leave anyone behind.

An honorarium (\$500 last year) is paid to each dorm mom. In addition, you are reimbursed for mileage from your home to PLU. If you opted to be a dorm mom in eastern Washington camp, you would get mileage to Cheney.

**Call to Order:** In Mary Chesney's absence, President-elect, Judy Prince, called the meeting to order at 1:55 p.m. Guests present were Carolyn Cliff, Carrie Richardson, and Qing Zhang.

**Minutes:** January 9, 2020 Meeting – Jackie DeFazio motioned to approve minutes as printed in the January newsletter; Anne Milton seconded; motion passed.

**Treasurer's Report:** Nancy Voelckers presented the financials for January. As of January 31, 2020 the combined balance in Operating and Scholarship accounts was \$76,759.30. Annual report was filed in January 2020.

\$20,000 CD at Coastal matured February 2, 2020. Nancy reported the board approved her recommendation to open a 5 month CD maturing July 2 for \$15,000 leaving \$5000 available to pay Purses with Purpose deposits for Camano Center and the auctioneer due now. Funds for the Tech Trek due March 1 are available. MaxGiving refund mentioned at the board meeting has been received.

**Tech Trek:** Tech Trek applications have been received. Interviews to begin and eleven campers will be selected.

Dorm mom for Tech trek is needed. There is a \$500 stipend plus reimbursement for round trip to the camp.

**Scholarships:** Season opened February 1 for four \$4000 scholarships. Must be at least a junior or in a master's program to qualify to apply. Applications are at the Stillaguamish Center, libraries, Stanwood Community Resource Center, washboard.org and on our website.

**New Business:** Day Tripper Activity Leader(s) are needed for 2020-2021. Please contact Mary Chesney if you are interested.

*Nominating Committee* is comprised of Kathy Cunningham, Mary Raymond and Norma Mouton, has met and ready to solicit nominations. Mary Raymond reported that Jeanne Garrioch has stepped up to take the position of VP Finance-elect. Other positions are President-elect (2 year term), VP Membership (2 year term), VP Program (2 year term) and Secretary (1 year to finish out Linda Lynn's term). Linda Lynn is not continuing as Secretary for the second year of her two year term, therefore, a replacement for one year is needed.

**Old Business:** *Purses with Purpose 2021:* Gay Campbell and Jackie DeFazio have stepped up to chair the 2021 PWP event. Date is October 9, 2021 and will be at the Camano Center once again.

Joint State Convention will be April 17-19 in Vancouver, WA. Kim Churches, National AAUW President, will be the Friday night presenter. Let Mary Chesney know if you are interested in attending.

**Announcements:** Jackie DeFazio announced it was the last day to urge your congressman to support extending the due date for the Equal Rights Amendment. Please see the email from AAUW. It was also reported that the House of Representatives eliminated the deadline earlier this day; next is passage by the Senate.

Mary Pilkington announced the play "Carried by the Current" on March 7 1:00 p.m. at the Camano Schoolhouse. This production is in honor of Women's History Month.
