High School STEM Scholars

Nurture or nature?

Much debate goes into the talent of artists, and whether or not it comes naturally or must be developed, but the same is true for scientists.

In its effort to advance gender equity for women and girls, the Stanwood/Camano branch of the American Association of University Women (AAUW) annually honors several high school juniors who excel in the sciences at the Stanwood, Arlington, and Lakewood High Schools. "The students were identified by the schools' faculty as outstanding scholars," said Leslie Moore, the High School STEM Scholar chair of the local AAUW program. "This is part of AAUW's national effort to encourage girls and women to pursue careers in STEM," Moore said. Most of this year's honorees acknowledge an early interest in science... with a bit of nudging from their parents.

Like Avery Zill, a science student at Stanwood High School, "One of my earliest memories of interest in science was being the only first-grader in my class who wanted to dissect a cow eye.". Since then, her interest in science was broadened by several role models in STEM fields.

For Audrey Ziemer, the engineering STEM Scholar at Lakewood High School, a passion for the sciences began in middle school when she enjoyed the topics covered in her science classes. But she was really inspired when her dad took her to a lecture by astrophysicist Brian Cox. "The lecture was really intriguing," Ziemer said. "I was so curious that I went home and did some more research."

"I appreciate that AAUW is bringing more visibility to women in sciences in order to break these stereotypes," Audrey Ziemer said.

Arlington High School's engineering STEM Scholar, Victoria Applegate found a natural talent in science and math, which she attributes to both parents. She found an ability to excel in science and math and was lucky to have some good teachers that kept her interested.

The Stanwood High School STEM Scholar for technology, Emily Molstad found herself to be very passionate about her engineering classes in high school. She said she always enjoyed different STEM subjects, but it wasn't until an Engineering and Design class with Mr. Hanson that she could imagine a career in STEM. Stanwood's STEM Scholar in math, Hannah Woods, also found that the STEM subjects came easy for her.

That's something the local AAUW likes to hear. Each year, AAUW members work hard to make a difference in the academic lives of girls. They raise funds for projects like this with their Purses with a Purpose luncheon and auction which also helps pay entering eighth grade STEM students to attend Tech Trek summer camp.

"This year, to honor the students' hard work we are sending a letter of recognition for their student portfolios and a \$25 gift card" Moore said. While the reward is small, the girls appreciate the recognition.

"I am very thankful for this award," Woods said. "I am proud to represent my school and the women of my generation."

Applegate was thrilled to receive the honor from AAUW. "It's so satisfying to see all my hard work pay off," Applegate said. "They could have chosen many other talented girls." Ziemer agreed. "To be honored by AAUW means a great deal to me," she said. "I appreciate that AAUW is bringing more visibility to women in sciences in order to break stereotypes."

Eleanor Roosevelt and AAUW

Because our Book Group is reading two books about Eleanor Roosevelt (ER) this month, it seems a good time to remind us all of ER's connections with AAUW. Although ER herself was not eligible for membership because she never attended college, she became a member in 1929 when the New York City AAUW Branch awarded her an honorary membership as the state's First Lady. At the time, ER was close friends with the NYC Branch president Marion Dickerman and branch member Nancy Cook. In fact, the three women operated Val-Kill Industries, a business that employed local residents in making furniture and handicrafts.

Over the years, ER attended many AAUW branch meetings around the country, sometimes writing about them in her syndicated news column "My Day." In 1936, as First Lady of the U.S., she visited AAUW's national headquarters to discuss plans to gather materials to document women's contributions to the world, expressing dismay that major U.S. history books failed to mention a single woman. In 1959, she spoke at AAUW's national convention in Kansas City about the responsibilities of Americans as leaders of the noncommunist world.

In 1961, President Kennedy appointed ER to chair the Presidential Commission on the Status of Women, where she was joined by three other AAUW members who had been appointed to the 26-member commission. ER also asked AAUW's general director to serve on the commission's Committee on Education. The Commission investigated the social and economic conditions of women in America and recommended, among other things, the development of legislation to address workplace discrimination, maternity leave, and equal pay. In 1963, President Kennedy signed the Equal Pay Act into law.

In 1989, AAUW created the AAUW Eleanor Roosevelt Fund Award to honor ER's legacy to the world and to AAUW. The fund supports activists and scholars who work to remove barriers to women's and girls' participation in education, to promote the value of diversity and cross-cultural communication, and to develop greater understanding of the ways women learn, think, work, and play.


We need the involvement of every member of our branch, and here is what you can do now to help us succeed in our goal:




Thank You's from Stanwood Elementary

300 degree oven 16-19 min.

Mix in one bowl, drop by spoonful onto cookie sheet lined with parchment paper:

- 1-3/4 cup powdered sugar
- 1/2 cup Hersheys Dark Cocoa powder
- 2 tsp cornstarch
- 1/4 tsp salt
- 2 egg whites
- 1 cup coarsely chopped pecans or walnuts
- 1 tsp vanilla (opt. 1 t. instant expresso coffee-I use Megaglia D'Oro)
