Public Policy: AAUW-WA Priorities in Our State Legislature Anne Milton

April 23 is the final day of the 2023 legislative session. This article will highlight those WA-AAUW priority bills that are still alive as of March 20 and will hopefully pass through the final committees.



State-Sponsored Apprenticeship Program - 2SHB 1013 establishes regional

apprenticeship programs for Washington state students. These programs would allow students to participate in a state-run apprenticeship program in high school that would offer students experience in different fields that may not require a college education.

Working Connection Child Care – 2SHB 1525 (WCCC) helps eligible families pay for childcare. When a family qualifies for child care subsidy benefits and chooses an eligible provider, the state pays a portion of the cost of childcare. This bill would provide qualifying applicants and consumers of state registered apprenticeship programs eligibility for the Child Care subsidy. Unemployment Insurance Qualification - ESH 1106 This bill relates to the qualifications for unemployment insurance when an individual voluntarily leaves work. Currently, if a worker is forced to quit their job due to inability or inaccessibility to childcare, the employee is ineligible for unemployment insurance. This bill allows for workers to qualify for unemployment insurance benefits while searching for new jobs.

My Health My Data – ESHB 1155 would block websites and apps from collecting and sharing health data. It would prohibit the sale of health data, the use of geofences (location-based software that identifies when a person is in a certain area) to send unsolicited messages to persons at health facilities. It requires companies that collect personal data to create, maintain and publish a privacy policy for consumer health data.

Preventing and Responding to Harassment – SHB 1207 The Office of the Superintendent of Public Instruction (OSPI) must develop model student handbook language that includes information about policies and complaint procedures related to discrimination, harassment, intimidation, and bullying. All schools would be required to designate one person in the school district as the primary contact regarding compliance with state laws prohibiting discrimination in public schools.

Supporting Crime Victims – 2SHB1028 (passed) HB 1028 has several important provisions that support crime victims by promoting a victim-centered, trauma informed response by the legal system. Law enforcement agencies must investigate a reported sexual assault within 90 days. Hospitals and emergency medical facilities located in WA cannot charge for the examination of a victim of sexual assault.

Meet Our Members Gail Merrick

Editor's Note: It's been a few years since we featured personal interviews with members; we wanted to bring it back. Hope you share the benefit of knowing other members.

I grew up in Normandy Park, WA, with my parents, my two younger brothers, and a variety of dogs and cats. Normandy Park was a quintessential 1950's community of midcentury modern and ranch homes, where doors were open to the neighborhood kids, where kids walked or rode their bikes to school and spent the summer at the beach and community pool. There was a horse boarding farm across the road, so my parents finally gave in and I got my first horse at age 9.



In the 1960's Boeing transferred our family to Huntsville, AL for the NASA Apollo Space Program. The windows of our schools and homes would shake and rattle when the rockets were tested! It was exciting times, culminating with the Apollo 11 moon landing.

I found the boarding stable, made new friends, and got my next horse. We could ride for miles across the hills under the TVA lines. I never did really get use to the humid heat. During the summer, we'd go riding early in the morning and again late in the evening. Our family spent weekends waterskiing at Lake Guntersville.

This was during the Civil Rights movement and racial unrest in Alabama. My high school was not integrated until my senior year. I'm certain my parents felt the culture shock more than I did. Waiting for our house to be ready, we lived in a motel and took our clothes to a laundromat. The sign on the laundromat read "Whites Only". In all seriousness, my mother asked where she could wash our colored clothes.

I loved our family's years in Huntsville. I have wonderful memories and life-long friends. But, when it was time to go to college, I was ready to move somewhere new. I graduated from Rocky Mountain College of Art, Denver, Colorado. I received my Vocational Education Certificate from Central Washington University and earned National Board Professional Certified Teacher.

I entered my career at a time when a woman working in an advertising agency was also expected to type and make coffee. I didn't do either of those tasks well, so I worked in retail advertising as an ad designer and fashion illustrator for the May Company, Denver and Nordstrom, Seattle. With what I thought was enough experience, I began my 27-year freelance graphic design/illustration career in San Francisco and Seattle.

During those freelance years, I also taught weekly retail advertising and fashion drawing classes at The Burnley School of Professional Art and the Art Institute of Seattle. I taught occasional semesters at Highline Community College, Sno-Isle Skills Center, and Western Washington School for Apparel Design and Fashion Marketing.

While I was raising my two young sons, I offered private children's art classes in my home, and I was invited by PTA groups to do classroom art sessions. I designed brochures in trade for preschool tuition and private swim lessons. I discovered a community of entrepreneurial moms working from home for whom I could help with their advertising and still be home with my sons.

When my husband and I moved our family to Stanwood in 1992, I produced a newsletter for the Stanwood-Camano School District and designed informational brochures for the Maintenance and Operation Levies. In response to this project, I was offered the opportunity to develop a Graphic Arts Program through Career & Technical Education (CTE) at Stanwood High School. Working with high school students was different from working with college students, but these teenagers made teaching so much fun. I was able to start an AP Studio Art Program that helped them win Scholastic Art Awards, be accepted to summer art programs, and earn college scholarships. The next twenty years was an exciting and rewarding second career.

My grandchildren are my most fun, fascinating hobby! They are sunshine to my soul. I love making board books for them and drawing their portraits. Even though my career has been about art, I still like to create for myself or for others. In retirement, my studio is my sanctuary where I have the time to explore other mediums. I still have fun doing messy art projects at my kitchen table with my grandchildren and neighbor children. I enjoy creating peaceful indoor and outdoor spaces at my home, for myself and for entertaining friends and family. I have help with my gardening and lawn maintenance, now, but I'm always on the lookout for interesting garden art. I've spent way too many hours researching and building family ancestral trees on Ancestry. I like to keep learning new things. I enjoy reading about artists, historical fiction, and watching Great Courses.

Before I was married, I traveled up the East Coast and spent a summer on Cape Cod. My best friend and I traveled from NYC to Stockbridge, Mass to visit all things Norman Rockwell. My husband and I made two trips to England. We traveled a lot in the Northwest. Of course, we took our children to Disneyland.

What would surprise us about you? With my three best friends, I screamed at the Beatles from the fourth row at the 1966 Memphis concert. I was honored to be chosen by my peers as the Washington State Secondary Art Teacher of the Year 2009

Reasons for joining AAUW: I was aware of AAUW because, in the past, I volunteered my art students to help with AAUW events. They loved modeling purses and wrapping artworks. Then, I was asked to come to a meeting where my friend and colleague, Marianne McGarry Bloom, was giving a presentation. I was interested in finding a good book club and it seemed this might be it. I have so enjoyed the books and the intelligent, insightful discussions.



Call to Order: Nancy Voelckers called meeting to order at 2:09 p.m., introduced guests and thanked the program team for a fabulous program. Nancy announced the state AAUW meeting on April 15 will now be only Zoom with speakers in the morning and the business meeting in the afternoon.

Secretary: Georgi Proulx presented February 9, 2023 minutes for approval as printed in the March newsletter. Motion to approve: Martha Huyler moved, Kaye Sodt seconded; motion approved.

Treasurer: Judy Trammell reviewed the financial reports for February. Operating account had \$3779.25. Total assets are \$83,505.88. Activity on the accounts was dues, SCAF receipts and February program.

Membership: Joanne Drewsen shared we now have 54 members and most of them are volunteering to engage in activities within the branch. She requested membership continue talking about our organization to encourage friends to join us.

Programs: Rose Olson announced April 13 is Tracy Gilroy at the Camano Library discussing women and finances. May 11 is the High School STEM Scholar Recognition and introduction of our 2023 Tech Trek campers at the Stanwood United Methodist Church 7:00 p.m.

Public Policy: Anne Milton has researched the Equal Rights Amendment reporting 38 states are required to ratify; this has recently occurred. The US Senate is developing a resolution to codify and discontinue the arbitrary deadline. She reported our state's health act was shut down in the House, but the ban on assault firearms passed in the state House and Senate.

Tech Trek: Mary Chesney reported sixteen nominations resulting in twelve applications having been received. All the applicants will be interviewed. The candidates seem to have investigated Tech Trek and are familiar with the program. Due to the cost of camp rising \$300 to \$1400, the Board discussed and decided to increase the budgeted number of campers to eight. Mary mentioned that donations for additional campers can be made by donating required minimum distributions which has the benefit of reducing taxes on this income. Final determination of our campers will be made the end of April. Mary also announced that she has accepted the state Fundraiser Coordinator for Tech Trek.

There was discussion regarding how we can increase the number of campers to twelve and use the expected funds from 2024 to pay for them. Nancy Voelckers explained the discussion and rationale of the board decision; PWP 2024 is after we spend and plan for 2024 therefore not feasible to use its proceeds. We are hoping for a big return at SC Give for 2024 camperships, and India Nishi will continue looking into AAUW state funding to add additional campers in 2023.

Scholarships: Marianne McGarry-Bloom shared that she has scholarship flyers and applications for the membership to take for friends that might have an interest. She also made it clear that males may apply; PhD candidates should apply for grants through national. Marianne and Mary Pilkington will be distributing flyers in La Conner. The committee will meet in May to select the recipients and award them at the Camano City Schoolhouse tea on June 25. There has been publicity in the Crab Cracker, Stanwood Camano News and the state scholarship site, theWashBoard.org.

STEM Scholars: Lael Williams reported she and Linda Demetre were very impressed with the three counselors they have been working with at the high schools. The honorees will be announced April 1 and honored at our May 11 meeting at Stanwood United Methodist Church at 7:00 p.m.

DEI: Nancy reported for Katie Farrey the DEI document has been completed and a presentation is being developed to be distributed.

PWP 2024: Georgi Proulx presented the committee chart for PWP thanking those who had stepped up so far. Still needed are table set up, bagging, and staffing coordinator plus leads for grants, sponsorships, Fund A Scholar video, raffle, and auxiliary item procurement. Our event kick off will be at our April 13 meeting by collecting purses. Every purse brought in will be exchanged for a raffle ticket for prizes to be awarded at the end of the meeting.

Nominating Committee: Nancy Roberts announced Linda Lynn is the candidate for Secretary and Robin Hanks for VP Finance-elect. President-elect remains unfilled.

Nancy Voelckers shared that Elaine Richards will not be able to lead the Candidate Forum in October. The board is looking for a leader for this important community event.

Activity Groups:

Book Group: Next book is Daughters of Yalta by Catherine Grace Katz for April 3.

Movie Group: It was suggested that we watch for Steven Spielberg's coming-of-age drama *The Fabelmans*, a movie loosely based on the filmmaker's childhood.

Day Trippers: Lynda Buehring reminded us the next outing is April 19 to Bellingham. Please RSVP by April 12 so carpools can be arranged. She also teased of an early June outing to be announced.

JAVA Break: Next gathering is March 15 at the Cookie Mill.

Publicity: Discussion was begun on the need for the coordination of the publicity for the branch and its various activities. We are finding that a managed publicity plan would increase our visibility in the community and people would learn what AAUW actually means and accomplishes. Discussion and further action is forthcoming.
